RELEASE AND INDEMNIFICATION AGREEMENT

My team, my crew and I agree and understand that the NANTUCKET ANGLERS' CLUB, its directors, officers, employees and agents (hereinafter collectively referred to as NAC) shall not be liable under any circumstance for any injuries or damages to persons or property, arising out of, resulting from, or in any way connected with me or my crew's participation in any tournament whether caused by any negligent act or negligent omission of NAC, or by any other reason or cause whatsoever. In consideration of the acceptance of my team and crew's entry and for other good and valuable consideration, liabilities, losses, damages, costs or expenses which our team or our heirs, executors, administrators, legal representatives, successors and assigns may have against NAC, arising out of, resulting from, or in any way connected with my participation in any tournament are hereby released. I understand that this release includes any claims based on any negligent act or negligent omission of the NAC.

To the fullest extent permitted by law, my crew and I hereby agree to indemnify, to defend with council acceptable to the NAC and to hold harmless NAC, from and against any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses including but not limited to reasonable attorney fees, suffered by NAC or by any person or persons, whatsoever, arising out of, resulting from, or in any way connected with my participation in any tournament including any and all claims, suits, obligations, liabilities, losses, damages, costs or expenses caused in whole or in part by any negligent omission or NAC or anyone for whose acts NAC may be liable regardless of whether it is caused in part by a party indemnified hereunder.

This agreement shall take effect as an instrument under seal and be binding upon and endure to benefit any of my, my team's and my crew's, heirs, executors, administrators, successors and assigns
